Truly, chaos reigns supreme when it comes to McGinley center, Collins Hall, and Walsh Library, where construction workers mill about, the road can be blocked off, and all assortments of jackhammers and clanging can be heard.

At McGinley center, things are poppin'. Although fenced off, you can enjoy a wonderful view of rocks, dirt, and heavy machinery from the cafeteria, McGinley second floor, or Hughes Hall upper floors. The Trump Administration's Syria Policy

October 6th the Trump Administration drastically modified its policy on the U.S. Military presence in Syria. The Trump Administration allowed Turkey to take a more aggressive role in Kurdish-held territories backed by American troops, and also withdrew American troops from key locations in Kurdish-held Syria. Despite the success of the raid that killed ISIS leader Abu Bakr al-Baghdadi, many foreign policy analysts believe that the United States has lost its foothold in combating the Assad Regime and preventing the spread of ISIS in the region. The United States' longtime ally in the region, the Kurdish Syrian Democratic Forces (SDF), has lost ground to Turkey, a NATO ally of the United States.

President Donald Trump gave implied approval for the Turkish invasion of Northern Syria on October 6th to Turkish President Recep Tayyip Erdogan. President immediately Erdogan mobilized Turkish troops to invade Northern Syria. The initial invasion displaced over 200,000 civilians and killed 200. Kurdish troops were unable to hold their ground as the Turkish military had received a green light for invasion from President Trump. In an act of desperation, the Kurdish Syrian Democratic Forces did the unthinkable and allied with their longtime enemy: the Assad Regime. The move not only allowed the regime's forces to gain territory in Syria, but also allowed Russian forces to enter areas under American protection just days before in order to limit the Turkish incursion.

President Trump ordered the withdrawal of American troops in Northeastern Syria in order to limit the possibility of American forces fighting Turkey a NATO ally, however, only approximately 50 of the 1000

troops were immediately withdrawn from the area. On October 11th news reports emerged of American Special Forces troops almost being wounded by Turkish artillery strikes in the city of Kobani that was near an outpost of American advisors. American special operations forces have remained close to or near various SDF bases. The U.S. Military, realizing the imminent danger of such strikes, immediately ramped up the withdrawal process. On October 13th, Secretary of Defense Mark Esper announced the administration's plans to withdraw all American forces currently in Syria in order to prevent American troops from taking contact with Turkish, as well as Syrian and Russian forces trying to counteract

Senator Romney's Alter Ego "Pierre" Flames Online Haters

Aside from being the world's only strangely attractive Mormon Republican senator from Utah who actually hates Trump, Mitt Romney (who I call Mittens affectionately) is also apparently an internet lurker.

Last month, The Atlantic published a profile of Romney, one of the few highprofile Republican lawmakers that have criticized President Trump's efforts to pressure Ukraine into investigating Democratic rivals. Trump's attempt to influence the 2020 presidential election through foreign interference has recently launched an impeachment inquiry by House Democrats. After the article was published in The Atlantic, Trump lashed out online, attacking Romney in a series of tweets that included the hashtag "#IMPEACHMITTROMNEY."

In the profile, Romney revealed the

existence of his secret Twitter account to the writer of The Atlantic's profile, McKay Coppins. The Utah Senator admitted to using the alias profile "to keep tabs on the political conversation" and to occasionally defend himself online.

Initially, he refrained from disclosing the name of the account, but instead revealed the number of profiles that he follows (702 to be exact) and outlined the types of users that he follows. After this information was publicly published, speculation swirled online as to what Romney's covert online identity would reveal, until a writer for Slate, Ashley Feinberg, took it upon herself to unearth the secret profile. After scouring the public Twitters of the Romney family tree, Feinberg struck gold while scrolling through the followers of Romney's oldest grandchild, Allie Romney. She found Twitter user @gaws9876, also known as Pierre Delecto. Once Feinburg conducted a thorough stalk of the profile and its followers, she was entirely certain that Pierre was

According to Feinburg's research, Pierre's online presence was born in 2011, exactly one month after Romney announced his 2012 presidential run. His first follower was Romney's eldest son, Tagg. The account then followed all of the Romney children, grandchildren (ultimate clout grandpa) and several of his former advisors, in addition to political commentators, politicians, late-night show hosts like Conan O'Brien and Jimmy Fallon and former NFL players such as Tom Brady and Brett Favre. It became evident that this user was indeed Mittens' as no normal person would ever follow more than four Mitt Romney fan accounts at one time. Additionally, although his tweet count is low (10 tweets total), Pierre has sagely replied to a variety of Romney-related commentary over the

years. He most recently responded in May to Jennifer Rubin, a conservative blogger at The Washington Post, who called Romney's strategy on Trump's "non-confrontation verging on spinelessness," to which Pierre replied: "Jennifer, you need to take a breath. Maybe you can then acknowledge the people who agree with you in large measure even if not in every measure." (Sacré bleu!) Needless to say, Pierre is no stranger to the art of the roast.

After Feinburg published her findings, Coppins followed up with Romney to verify the allegations, to which Mitt simply responded: "C'est Moi." Since then the account has been made private, but the screenshots live on. In essence, if Mitt Romney can tell us anything, he reminds us through Pierre that we can all be our own hypemen. Taking Hate to Court

Here in America it is not unusual to see people hailing from different countries from around the world. It can often be thought that America is the "Great Melting Pot," infused with people who add to the cultural richness that makes America so unique and unlike other nations. Despite this, however, it must also be acknowledged that there do exist racial tensions which not only divide America as a nation but divide us as a people too.

The Charlottesville racially motivated riots of 2017 not only spurned violence by white supremacists but also incited more tensions. A new case regarding the riots will be tried before a jury in the summer of 2020. The specific details of the torch lit protest are not clearly identifiable and attorneys have differing opinions as to why certain events happened and what their arguments are for the court.

The Lawsuit Taking Aim at the Charlottesville White Supremacists

Heyer who was against the white supremacists, induced great а amount of violence. The specific question, however, is whether the First Amendment protects this hate speech and whether the protests premeditated the violence or if it was



a result of the words and chants used. The defense lawyer W. Edward ReBrook IV claims that "The First Amendment is about protecting horrible opinions, not protecting reasonable ones." This seems reasonable except that oftentimes hate speech does lead to violence. Despite this, in order to prove

the white supremacists guilty of the death of Heyer and violent outrage, the plaintiffs must show that the acts led by the white supremacists involved violence prior to the protests.

Proving a conspiracy is the crux of the lawsuit, which is rooted in the component of an 1871 federal law commonly called the Ku Klux Klan Act, to re-enslave African-Americans. This act essentially protected the freedoms of African Americans who remained targets of Klan violence despite having been freed from the shackles of slavery, literally and metaphorically. The case now with Charlottesville is not much different than similar actions taken by neo-Nazis and the white supremacists in the past which essentially orchestrate violence based on racism and wrongfully prejudiced notions regarding minorities.

According to Ms. Sines, the leading plaintiff in this case, "Civil litigation allows us to hold those responsible for violence accountable in a way that other tools do not. If you plan and execute violence - toward Jewish people, people of color, diverse communities like Charlottesville you will be held responsible for your actions." The ongoing Sines v. Kessler case serves as the longstanding case protecting against racially motivated incidents involving racism.

Thus far in the Charlottesville case, which criminalized efforts by the Klan Judge Norman K. Moon of Federal District Court cited the Griffin case and the Ku Klux Klan Act in rejecting the defendants' initial attempt to have the lawsuit dismissed on First Amendment grounds. It seems that the case can be hopeful for the plaintiffs in the respect that there is evidence of premeditated violence in this situation and it seems clear that the white supremacists were not simply hoping to spread their hateful opinions but did get physically involved with those disagreeing with them. It is in this vain that hopefully this case can positively conclude bringing justice to the plaintiffs and those who were wrongfully hurt, either physically or emotionally, by the white supremacists.

Small Step of Progress for NCAA Student-Athletes


The NCAA's board of governors met this past Tuesday, October 29th with a new response for student-athletes and their supporters vying to profit off

and their supporters vying to profit off their name, image and likeness. The collegiate governing body announced it will allow student-athletes to take advantage of sponsorships across its

three divisions. This has been a hotly contested issue in the past decade, especially due to news surfacing periodically of these athletes accepting or soliciting compensation from potential schools. Some examples that have floated around in recent years involve Phoenix Suns professional basketball player Deandre Ayton's time at Arizona, or Cam Newton, quarterback for the Carolina Panthers. whose father tried to extort Mississippi State. With new rules, athletes could openly receive a

compensation separate from their school without penalization. For athletes, this means the possibility of hundreds of thousands of dollars in sponsorship for those stars in top tier programs. However, even students in smaller schools could benefit from endorsements in their local community.

This news comes a month after the California legislation on the same matter passed by Gov. Gavin Newsom, or the "Fair Pay to Play Act." The law details that athletes at California universities will be able to accept endorsement deals. The act allows student athletes to use their name and likeness to earn money in a similar fashion to professional athletes, but this does not entail having the schools directly paying the athletes for their time. At the time, the NCAA considered the law dangerous and "unconstitutional." The organization's concern is if a state like California allows their college athletes to have sponsorships, then these schools can have a comparative advantage in getting top-level recruits. Newsom himself described the situation best, while signing the bill on LeBron James' media platform Uninterruputed, "I don't want to say this is checkmate, but this is a major problem for the NCAA. It's going to initiate dozens of other states to introduce similar legislation, and it's going to change



now the interest finally of the athletes on par with the interests of the institutions. Now we're re-balancing that power arrangement." Some states that also acted with new bills include New York and Florida, and federal politicians have shown interest to work on the case on a national level through Congress.

Thus, the NCAA's decision to support college athletes having endorsements is the group's reaction to such initiatives. Michael Drake, chair of the board for the NCAA and president for Ohio State University, commented, "We must embrace change to provide the best possible experience for college athletes." Additionally, the president of the NCAA Mark Emmert, in closing of the statement, asserted, "As a national governing body, the NCAA is uniquely positioned to modify its rules to ensure fairness and a level playing field for student-athletes. The board's action today creates a path to enhance opportunities for student athletes while ensuring they compete against students and not professionals."

Even with this news, politicians, athletes, and representatives in the sports industry alike are skeptical of how much change the NCAA will commit to. Some notable figures include politician Nancy Skinner who sponsored the California bill. Skinner tweeted, "California's leadership is a game-changer once again! The NCAA's announcement shows promise on giving college athletes' NIL rights. But the devil is in the details on what the NCAA means by adhering to the 'collegiate model." Former Olympic skier Jeremy Bloom also found the details, or lack thereof, to be a sign of false advertising. Bloom has previously battled the NCAA after they forced him to be ineligible for two seasons of his collegiate football career in Colorado, due to endorsements he recieved from skiing.

Skinner, Bloom, and other sports figures see the "collegiate model" term to be an attempt to hide how far the NCAA is actually willing to go. Bloom's fiery response to the NCAA statement was, "Bottom line, state legislators need to continue down the path and keep the pressure high while the NCAA figures out how to hold up their house of cards." To Bloom's likely approval, other legislators agree. Florida legislators, like state representative Kionne L. McGhee. found the NCAA's statement positive, but not the end of the fight. McGhee stated, "While this is a great first step, we must ensure Florida's studentathletes are provided fair treatment and long-term protections found in my bill, HB 251."

The organization gave the three divisions a timetable of January 2021 to create the new rules. Notably, in their statement, the NCAA has yet to outline any other specific steps for this transitory process. However, the organization has emphasized that they will still support student-athletes as students first. And these students will not be given preferential treatment over non-athletes beyond that deemed necessary to accommodate for their commitment to the school.

ISIS Leader Dead Following U.S Operation

On Saturday, October 26th, President Trump tweeted out that "Something very big has just happened!" Curiosity, excitement, and slight panic by some ensued until it was revealed the next day by the President that Abu Bakr al-Baghdadi, the leader of ISIS, was dead following a U.S Special Forces operation in northwestern Syria. U.S Intelligence had long been trying to capture or kill al-Baghdadi, and he is the most prominent terrorist leader that has died as a result of U.S operations since the death of Osama bin Laden in 2011.

Al-Baghdadi had been under surveillance for multiple weeks preceding the operation. While the actual raid was conducted solely with U.S troops, it was made possible through the cooperation of U.S, Kurdish, Iraqi, and Turkish intelligence, who worked together to obtain information on the terrorist leader's frequently changing direction from his close informants. Once U.S troops became confident on the location and details of al-Baghdadi's compound, they began the raid.

President Trump remarked that the most dangerous part of the operation

local gunfire which they quickly eliminated as they neared the compound. Trump believed this gunfire to be not from any organized group or nation, but rather "people that were shooting that were indiscriminately shooting... we think that these were people that were just random people that don't like to see helicopters, I guess."

The president stated that the U.S informed Russia and Turkey prior to the operation that they would be flying over their territories, to which the countries accepted, despite not being told the reason or destination of the flight. The same route was taken both ways, before and after the raid, and, in addition to the low flying helicopters, air support flying high was also present throughout the operation.

Once the U.S Special Forces landed on-site, they began to infiltrate al-Baghdadi's compound. The front door of the complex was rigged with booby traps, and so the soldiers used explosives to gain entry through the side of the building. Troops remained inside for two hours, during which eleven

As the building was cleared, al-Baghdadi fled into a dead-end tunnel with three of his children, all the while being chased by U.S K9 units. Once in the tunnel, al-Baghdadi ignited his suicide vest, killing himself, three of his children, and collapsing the tunnel.

Al-Baghdadi's body was mutilated by the blast, though on sight DNA lab technicians were nonetheless able to obtain a DNA sample and confirm a positive match between the man that blew himself up in the tunnel and previously obtained al-Baghdadi DNA.

Trump remarked that U.S troops were able to obtain "highly sensitive information" on ISIS, specifically in regards to their origins and future plans. Trump noted that he decided not to notify Speaker of the House Nancy Pelosi and other congressional leaders because "Washington leaks like I've never seen before... Washington is a leaking machine." 

Both Secretary of Defense Mark Esper and Chairman of the Joint Chiefs of Staff Mark Milley were unable to confirm Trump's descriptions.

ISIS acknowledged the death of al-Baghdadi and has already appointed a new leader, by the name of Abu Ibrahim al-Hashimi al-Qurashi. American intelligence will continue to examine the new structure of ISIS and seek information on its new leader's past and present roles within the organization, as the War on Terror continues to rage on.



It is spooky season, which means that it's time to send in the clowns... for better or worse.



When your flight gets cancelled because of civil unrest in your destination city, there are two options. 

Onion's Book Made Us Cry: Stones to Abbigale is Wretched

Stones to Abbigale is a "book" by Gregory Jackson, known online as Onision. This "book" is self published; he wrote it after not reading a book for 14 years. Everything about this work is a muddled mess; I've read it at least ten times trying to understand why someone would write this. It is my Vietnam.

Stones to Abbigale has one main character, James, who serves as a stand in for the author. This isn't a deep analysis. Greg boasts "James is essentially a better version of myself. His home, his school & his life all resemble my own at his age. The people James analyzes and is surrounded by are not so unlike those I've known as well." in the description for his book on Amazon. It's ironic that the people James is surrounded by are based on real people Greg knew, because Greg writes human beings with the same level of insight as someone who was introduced into society for the first time at 20 would write. With that in mind, it might be interesting to look at some of the more prominent secondary characters to understand how Greg views other people.

Besides James, the most important character in Stones to Abbigale is, of course, Abbigale. She is James' love interest and the embodiment of pity porn and not much else. She has one (1) moment of agency, where she berates James for assuming she is "broken," and it's one of the only good moments in the book. This is of course undercut by Abbigale breaking down and admitting that yes, she is broken

and that shes so so thankful James noticed. Even though Abbigale is the second most important character. she's only important in how she serves James. She either serves as a figure for him to save or a figure to give him love. Their relationship isn't one that can exist in real life, especially considering Greg's abysmal and abusive track record with love.

Davis is James' best friend, though that term is used loosely. In reality, Davis is more like an obsessive fan, someone who exists only to cheer up James and say things like "Hallelujah, James is here to save us from the evil clouds!" It's heavily implied Davis is in love with James, even after James negs him for feeling emotionally wrecked after surviving a school shooting. Davis later gets run over and dies like a dog in one of a series of horrific events that Greg uses to inject pathos into his empty, banal story.

Lisa, James sister, is treated as an afterthought, therefore she's my favorite character out of spite. James hates her because she gossips all the time and apparently has a lot of boyfriends. Greg is merciless in making her out to be this screeching banshee, describing her as someone "...who thought she was so important, everyone around her just had to hear everything she had to say no matter how trivial the topic." Later, Lisa's friend dies in the school shooting, and from the little we are told, Lisa is distraught. James shows no sympathy to his sister, or any to any character besides Abbigale, and even slut-shames her when he notices she's upset. When James' mom leaves their home to live with her boyfriend in Spokane, Lisa leaves with her, and with that leaves the story.

Hopefully it's clear that James (and Greg) treat people objects that provide a service. His cold and clinical treatment of others is a character trait. James describes how he has "enjoyed seeing how people move around and talk to each other, like they're all animals at the zoo." This book is poorly written, but even if Greg wrote on Hemingway's level, it still suffers from how terribly Greg treats the secondary characters.

Just when I thought Onision couldn't get any more inconceivable as a human being, I found out that he is the author of three self-published books. The first of these, Stones to Abbigale, is nothing short of a literary masterpiece-riddled with grammatical errors, spelling mistakes, and one-dimensional characters, it did not fail to meet my already high expectations of Onision's writing.

The book opens with the story's protagonist, James, ruminating on just how special he is because he doesn't like anything. A troubled soul, James isn't like other guys: he always feels like "an alien who had a VIP pass to submerge [himself] in primitive human culture just for entertainment." Unable to relate to any of his peers, James braves the world alone -- that is, until he meets Abbigale, a girl who is somehow different from the rest of the students at James' high school. to Davis, a.k.a. the Human Sycophant Prop. Several shenanigans ensue, including James "saving" Abbigale from her abusive ex-boyfriend, a school shooting, Abbigale moving in with James, and the protagonists' school burning down. Thank goodness for the reader, James and Abbigale's totally healthy and normal relationship stands the test of time.

I'm going to be blunt: this book is a shitshow. Onision isn't wrong when he calls James an alien because 90% of the interactions he describes wouldn't ever take place in reality. You've got romanticized abusive relationships, teachers calling students the F-word with zero repercussions, and the craziest, most unhealthy relationship between the two main characters painted as the epitome of human romantic interaction. This is High School Musical meets Law & Order in the worst way possible, and I don't hate anyone enough to recommend this book to them.

Paranormal Activity Who? Check Out the Lighthouse

Robert Eggers' slow-building, psychotic, occasionally homoerotic new film The Lighthouse is a masterpiece. Following his 2016 debut The Witch, Eggers has stirred the proverbial waters with his two-man horror period piece. The Lighthouse, written by both Eggers brothers, details the story of two crusty lighthouse keepers played by Robert Pattinson and Willem Dafoe.

Some of the most fascinating things about this film are its implicit or explicit references to literature. This is what I will primarily be talking about in this article and SPOILER ALERT I am unapologetically going to reference the entire plot. The film begins with shots of the two on a ship cleaving its way through the water towards the lighthouse in the distance. There is no ham-fisted exposition. Instead. details are slowly dropped here and there about why the two men are here. Slowly, we learn that Robert Pattinson has been enlisted to complete various chores for Willem Dafoe, a crotchety old seaman with a hell of a pirate accent.

Throughout, Pattinson fetishizes a mermaid carving, violently kills a seagull, and obsesses over the light at the top of the lighthouse that Dafoe (who is, possibly, a tentacle monster) himself fetishizes. In the end, Pattinson physically dominates and kills Dafoe, sees the light, falls down the lighthouse and is picked at by seagulls while still alive.

Probably the most important reference to literature in the film is the explicit reference to Prometheus. At the end when Pattinson is burying Dafoe alive, Dafoe specifically references Prometheus in some of his last mad ramblings. The myth of Prometheus, first referenced in Hesiod's Theogony, details the story of a Titan who defies the gods by stealing fire and giving it to man. As punishment, the god was chained to a rock where every day an eagle would come to eat his liver and every day it would grow back. Dafoe's invocation of Prometheus

foreshadows Pattinson's theft of fire (light) and consumption by birds as

punishment.

The other integral reference to literature in the film is the implicit reference to The Rime of the Ancient Mariner. The Rime of the Ancient Mariner is a norm by Samuel Taylor.


lines between sanity and madness become blurred, Pattinson more and more frequently encounters an actual, beautiful mermaid in what can only be described as "masturbation dream sequences." The mermaid, too, is no Ariel. She cannot speak. Instead, she only emits high-pitched inhuman shrieks. Nevertheless, her psychosexual grip on Pattinson seems more and more to pull him towards ultimate doom.

In this context, mermaid seems to represent one of the famous sirens from Homer's Odyssey. The sirens in Homer's Odyssey are creatures that lure sailors to their death with their irresistible song. While Homer's description of the sirens does not include "mermaid" features. seems like a contemporary trope to depict sirens as mermaids or beautiful, waterdwelling women. Eggers uses this myth to fashion a psychosexual siren. This siren may have had a role in Pattinson's predecessor's madness as well, since it is his predecessor's mermaid carving that induces a "mermaid fetish" of sorts.

Finally, let's return to Dafoe's last mad ramblings. As he is being buried alive the man references "Protean forms." Proteus, in Homer's Odyssey, is a shape shifting

sea-god. In order to gain knowledge on how to return home, Menelaus must capture the god. This theme is translated to the bizarre relationship between Dafoe and Pattinson. Dafoe is psychologically abusive and mercurial, but ultimately becomes overpowered by Pattinson (who makes him bark, roll over, and walk on a leash). The theme of "protean forms" is especially notable in the unsettling shots of unexplained tentacles.

The Lighthouse is a must-see for any fan of horror. The film is extremely enigmatic and going into it with knowledge of the plot and literary background won't help answer the unanswerable questions it posits. Nevertheless, the film is worth seeing if not for its literary background, then for its Kubrick-esque shots and brilliant acting. It certainly left me eagerly anticipating another Eggers feature.

Dafoe, early on, warns Pattinson that it's "bad luck to kill a seabird." Later, he states that this is because the seagulls contain the souls of dead seamen. Pattinson doesn't listen and, quite horrifically, bashes a seagull's skull in. Following this, Pattinson becomes trapped on the lighthouse's island due to weather and the two run out of rations, much like in Coleridge's poem.

Next, we should talk about mermaids. Pattinson, upon arriving, discovers a wooden carving of a mermaid hidden in his bed. Later, he learns that the man he has replaced went mad with delusions about the light atop the lighthouse. Presumably, the carving was his predecessor's.

Throughout the film, Pattinson pleasures himself to the mermaid carving. As time goes on and the

Bojack Horseman's Final Season Delivers

The final season of Bojack Horseman, which is releasing in two separate parts (with this review looking at the first half), is admittedly bittersweet. On the one hand, this show has meant so much to so many (including me) and it's genuinely sad to see one of the best shows still running get archived. On the other hand, the legacy of Bojack Horseman

is a great one that is—like any other great show—always one season away from leaving a black stain on what has been an otherwise near-perfect show. Thankfully, if the first half of Season 6 is any indication for the final half, the show is going to stick the landing.

The world of Bojack is one of change in the eightepisode first half. The end of Season 5 saw each character beginning new journeys and tackling new problems. Most main characters of the series get at least one episode that addresses their current situation. Of course, with such a large cast, these characters often interact within their daily lives, so episodes typically everybody at least momentarily. As the season progresses we see our cast sort out their lives in genuinely heartwarming ways. Diane, after her recent divorce from Mr. Peanutbutter, finds a

stable and supportive relationship with her cameraman, while Princess Carolyn discovers what it means to be a mother, and doubting herself as she questions whether she's forming a genuine connection with her child. Meanwhile, Mr. Peanutbutter finally works up the courage to sort things out with his girlfriend after cheating on her with Diane last season, and Bojack stumbles but ultimately succeeds in rehab after taking his situation into his own hands with Diane's help.

Towards the end of the first half of the season, the focus is on Bojack. In the penultimate episode of this first half, Bojack spends his time travelling around and reconnecting

with people he's hurt in the past. These include Diane and Hollyhock, Bojack's half-sister. The episode is a signal: Bojack is finally ready to put his past behind him and start anew as a good friend, a good brother, and an overall good person. It's a truly heartfelt episode, but in true Bojack fashion, the sentiment doesn't last. The last episode of the season is truly bizarre, and introduces strange new characters we've never seen before, resurfaces old one's that



have seemingly no bearing on the present story, and ultimately is a confusing mess. The closing seconds of this episode, however, bear an important warning for Bojack's fate heading into the final stretch of the series. Hollyhock mingles with a new friend she met at a party who recalls the story of his prom night in high school when a stranger crashed his friend group and bought drinks for the teenagers which ultimately resulted in a night at the hospital for one of his friends. His name was Bojack Horseman.

The more I think about this finale the more heartbreaking I interpret it. Looking at the final episode of this part, it's clear that the show is setting up a cast of characters that are going to resurface and rail against Bojack for the harm he's caused them in the past, with some of these injustices being highly illegal and certainly actions that could land Bojack in jail for the rest of his life. The show is in a position to make an important message about "cancel culture" and the MeToo movement. Bojack is clearly a changed person, and has actively sought in this season to mend hearts and establish himself

as a force for good in the future, but now his past actions are about to catch up with him. Now that push comes to shove, do we just throw Bojack away? Do we say his redemption arch never really made a difference in the grand scheme of things? For Bojack, the only thing that carried him through the ages was the hope that there was still time to overcome his troubled past, die a good person, and be someone others could look up to and love. Dying in jail would take any hope Bojack has fought to reclaim, and confirm his lifelong suspicions that he was broken from the onset, and that happiness is simply out of reach for some people. Not only

would it be a sad message for Bojack, but it is a sad message for us, the audience, and our personal lives as we overcome our own impediments and, for some, mental struggles.

So how do we deal with Bojack Horseman? It's a tight line for the show to walk. If he walks away untouched does it send the message that predators can get away with it? On the other hand, if Bojack's incarcerated for the remainder of his life, does that send the message that we are forever defined by our past actions, and that there's no reason in reforming ourselves? I'm not sure which direction the writers will go in the final eight episodes, but I sure am excited (and scared) to find out.

However, as Shane's previous "documentaries," or as many critics prefer to call them, "vlogumentaries" have proved to be problematic, with the use of questionable journalistic practices and uninformed deductions. Many viewers are left questioning the intent of the YouTube veteran's endeavor

into the makeup industry despite never expressing interest in it before.

The goal of Shane Dawson's previous series was to investigate (and also entertain defamatory conspiracies about) the lives of popular influencers. The main issue many held with these series was the biased, ignorant approach Shane took to examine these figures. Many of the questions posed by creator and viewer alike were either brushed over or completely ignored. Viewers still have no true understanding of Tana Mongeau's involvement with the planning and failure of TanaCon, if Jake Paul knowingly manipulates his young audience, or whether or not Eugenia Cooney has fully recovered from her eating disorder. Shane is no journalist, and in the case of exploring whether or not Jake Paul was a sociopath, is no psychiatrist either. Instead of answers, he presents melodramatic storylines that intersect each other repeatedly, creating a long-winded narrative that leave viewers begging for some sort of resolution; it is entertaining

nonetheless.

Shane was able to dodge many of these criticisms in his latest series, however, as it focused his personal experience with Jeffree Star in creating the "Conspiracy Collection," which consists of two eyeshadow palettes. a lip gloss collection, accessories, and an entire merch collection (that has already sold out). Viewers sit in on board room meetings, makeup labs testings, conference calls, and photoshoots. The two insist that what they are creating "has never been done in the makeup industry before." Perhaps showing the process of a large makeup collaboration, from the lab to the shelves, is impressive, at one point we are given an incredibly dramatic shot of a JFC employee calculating the projected earnings of the duo on his iPhone calculator app... it is hardly revolutionary. We are only given glimpses into the process, and in all honestly, they make it look easy. It appears the most difficult part of the launch was choosing the correct packaging, which had an entire "episode"

dedicated to it titled "The Failure of Jeffree Star and Shane Dawson," so sad! In all fairness, we do witness some wholesome moments, such as Shane's proposal to his boyfriend Ryland, a motivational speech made to Ryland's sister Morgan about subjective beauty standards, and a shot of Shane and Jeffree hugging as they watch eyeshadow pans get impressed with their names.

HOWEVER! This does not excuse the questionable intent of Shane. who throughout his entire career, had never expressed interest in makeup or the beauty community until his series with Jeffree. He makes an effort to address these concerns, doing makeovers on his friends and family in each of the videos. Yet this doesn't disguise the avaricious nature of the duo, who constantly allude to the grand amount of money to be made by the launch. They were successfully able to sway the hearts of millions into buying their collection: don't bother trying to purchase the Conspiracy palette now - it's already sold out!


J.D. Salinger May Be Gone, But His Legacy Lives On

On February 1st, 2019 the Guardian published an interview with Matt Salinger, son of "Catcher in the Rye" author J.D. Salinger, announcing that his father's unreleased works would finally be published. Despite continuing to write between the publication of his last short story, "Hapworth 16, 1924," which was published in the New Yorker in 1965, and his death in 2010, the author did not publish any new works, and often refused to comment on his writing and declined interviews. The younger Salinger stated that the first of the unreleased works should start to roll out in 2020 and that readers need to be patient because going through all that his father had written in the 45 years prior to his death is a big undertaking.

In August, Salinger's U.S. publisher Little, Brown. And Company released all of Salinger's current works in the form of eBooks. The publishing house even created an Instagram page for the famed author, fully bringing him and his works into the 21st Century. The hesitancy that the Salinger estate showed in releasing the eBooks and in preparing the unreleased works for **Experience history at the public library** publication demonstrates the care room on the library's first floor. the author's loved ones are taking to preserve his legacy and proceed with publication as he would have wanted.

Also teased in February's article



was an upcoming exhibition of Salinger's personal archives at the New York Public Library Stephen A. Schwarzman Building on 5th Avenue. The exhibit opened on October 18th and will run until January 19th, 2020. Last Saturday I had the opportunity to visit the exhibit and appease my moody-" Catcher in the Rye"-loving higher schooler soul. The exhibit is free to enter and housed in a small

> any phones at all inside and I was told at coat check that for security reasons, guests were not allowed to have anything on them that had large pockets. The exhibition room is incredibly tiny, not much larger than the average Martyr's Court dorm room, yet it was jam-packed with photographs of the author's childhood and days in the military during World War II

and letters he wrote to various book agents, publishers, family members, and friends. And of course, right at the entrance was the typewriter Salinger used to write most of his works, including "Catcher in the Rye," along with the original typescript of the novel. One of the most interesting aspects of the exhibit to me was the amount of memorabilia from his military service during WWII; the

author was present at the D-Day landing and at the Battle of the Bulge. It was at military school in Pennsylvania that Salinger began to write and was also the literary editor of his school's yearbook. Much of the works on display were Salinger's correspondence with his colleagues in the literary world. One work that struck me was a set of letters and drawings in which he meticulously

outlined what the cover of "Catcher in the Rye" should look like. The author's attention to detail was so apparent throughout the exhibit that I can't help but think that is the reason as to why we have had to wait so long to read his unreleased works, Matt Salinger wants to do his father justice and take as much care as he would have had he published while still alive. There was so much on display that there is no way it could be described in just one article, you'll just have to see for yourself. I wish I could have provided pictures, but honestly, I liked the no-phone policy, it made me actually spend more time contemplating what I was looking at. And one thing is for sure, I am anxiously awaiting the arrival of new Salinger fiction in the coming years.


brownies, she delivers the show's best line, which was amazing don't at me, it's a fact.

So who murdered the mayor? Well, now you'll never know.





